This passive and voiceless, confined within patriarchal norms creature could be let in modern literary narratives highlighting its agency, identity, and resistance. This paper explores the transformation of female representation from silence to empowerment in *The Scarlet Letter* and *A Doll's House*. Although these two literary works originate from different countries and historical periods, they share several similarities in their portrayal of female characters. Women across different societies and eras experience comparable forms of subordination and oppression. Both texts highlight the struggles of women against patriarchal norms and depict their journey toward self-awareness, resistance, and empowerment.

Introduction

Henrik Ibsen's *A Doll's House* (1879) is widely regarded as one of the most influential plays addressing the position of women in a patriarchal society. Set in nineteenth-century Norway, the play explores the social, cultural, and psychological constraints imposed on women. During the time when **Henrik Ibsen** wrote *A Doll's House* (published in **1879**), the condition of women in Norway reflected the broader patriarchal structure of nineteenth-century Europe. Although Norway was gradually modernizing, women still had limited legal, social, and economic rights.

Hence, Henrik Ibsen portrays the true picture of women's struggle through the character of Nora Helmer in *A Doll's House*. Initially presented as an obedient wife and devoted mother, Nora gradually realizes that she has been treated as a decorative object rather than an independent individual with her own identity and aspirations. The title of the novel itself suggests Nora as a Doll in the hands of her husband Torvald. She is expected to entertain and please her husband. Nora Helmer is portrayed initially as childish, dependent, and decorative piece. Her husband Torvald treats her like a possession rather than an equal partner, calling her pet names such as "little skylark" and "squirrel." This reflects how society expected women to behave—obedient, charming, and submissive.

"You have loved me as a wife ought to love her husband. Only you had not sufficient knowledge to judge of the means you used... No, no; only lean on me; I will advise you and direct you" Torvald

She has little authority or independence. Her identity is shaped by male control—first her father, then her husband.

"That is just it; you have never understood me. I have been greatly wronged, Torvald—first by papa and then by you. "I mean that I was simply transferred from papa's hands into yours. You arranged everything according to your own taste, and so I got the same tastes as you—I have existed merely to perform tricks for you, Torvald. But you would have it so. You and papa have committed a great sin against me. It is your fault that I have made nothing of my life" (Nora Helmer . Act 3)

As the play develops, Nora's true strength emerges. She secretly borrowed money to save Torvald's life, showing courage and responsibility. However, because women lacked legal and financial freedom at the time, she must have forged her father's signature. This reveals Women's dependence on men in legal and economic matters and the unfair moral standards applied to women .The play portrays the true reflection of patriarchy. as Torvald came to know this fact in the act three, he values reputation and criticizes Nora

"What a horrible awakening! All these eight years—she who was my joy and pride—a hypocrite, a liar—worse, worse—a criminal!" (Helmer, Act 3)

Ibsen critiques Male dominance in marriage. And Society's expectation that women sacrifice themselves for family.The most significant portrayal of women comes at the end of the play when Nora decides to leave her husband and children to discover herself. This was revolutionary for the time.

"Listen, Torvald. I have heard that when a wife deserts her husband's house, as I am doing now, he is legally freed from all obligations towards her. In any case, I set you free from all your obligations." Nora

Her decision symbolizes A woman's right to self-respect and independence. Rejection of traditional gender roles. The search for personal identity beyond marriage and mother Through Nora's transformation, Ibsen challenges the conventional ideals of marriage, family, and femininity. Although Ibsen did not explicitly identify himself as a feminist, his portrayal of Nora's quest for identity has made *A Doll's House* a landmark text in feminist literary criticism. The play continues to inspire discussions on women's rights, gender equality, and the importance of selfhood, making it a significant work for understanding the evolution of female consciousness in literature. In *A Doll's House*, women are portrayed not as weak beings but as individuals suppressed by social conventions. Through Nora's journey from dependence to self-awareness, Ibsen exposes the limitations imposed on women and advocates for equality, freedom, and individual.

The second literary piece of our study *The Scarlet Letter* (1850), written by **Nathaniel Hawthorne**, is one of the most significant works of American literature, set in seventeenth-century Puritan New England. The novel explores themes of sin, guilt, punishment, hypocrisy of morality, and social judgment through the experiences of its protagonist, Hester Prynne. *The Scarlet Letter* portrays the struggles of women against social oppression and gender discrimination. Hester Prynne is condemned and publicly shamed for committing adultery, she is portrayed as a woman condemned by her neighbors for having a child out of wedlock. She is imprisoned for having a child out of wedlock, convicted of the crime of adultery, and sentenced to be forced to wear a prominent scarlet letter 'A' (standing for "adultery") for the rest of her life. The beginning of the novel starts with prison house and second chapter marketplace where people are doing conversation about Hester:

"Or else you have surely heard of Mistress Hester Prynne and her evil doings; she raised a big scandal, and penalty thereof is death. thus, she will be a living sermon against sin" (neighbour p,70)

The study scrutinizes Hesters internal conflicts and suppressed emotions deprived of both the males of her life; her old husband Chillingworth left her for her study of medicine, and her lover

Arthur doesn't commit his love due to his social dignity of a clergyman; but she endures this anguish with firm determination in public:

"Never, you can't take it off; I would endure his agony as well as mine." (Hester ,p.77)

the novel delves deep into psychological tolls of Arthur Dimmesdale's guilt and revengeful nature of her husband Chillingworth. All the contradictions of Hester Prynne – guilt and honesty, sin and holiness, sex and chastity – make her an enduring heroine of American literature. She is flawed, complex, and above all fertile. She reveals immense mental strength not to accept her love as a sin publicly, while the male participant in the same act initially escapes public punishment. Instead of allowing society's condemnation to define her identity, she transforms the scarlet letter from a symbol of shame into one of courage, compassion, and personal integrity.

The novel also examines themes of female identity, independence, and resistance to oppressive social norms. Hester's journey from silence and suffering to self-respect and moral strength challenges traditional expectations of women and highlights the importance of individual freedom. Although Hawthorne wrote during the nineteenth century, his portrayal of Hester as a strong and independent woman has made *The Scarlet Letter* an important text in feminist literary criticism.

A further modern interpretation concerns social judgment and public shaming. Hester's public punishment resembles today's culture of online criticism and social media shaming, where

individuals are often judged without compassion. Hawthorne's novel reminds readers of the importance of empathy, forgiveness, and respect for personal dignity.

The texts also encourage a reconsideration of **marriage and relationships**. Ibsen argues that a successful marriage should be based on equality, mutual respect, and honest communication rather than authority and dependence. This idea closely aligns with contemporary views on healthy relationships.

Finally, both works demonstrate that **literature can be a catalyst for social change**. Their portrayal of courageous female protagonists has inspired generations of readers to question injustice and advocate for equality. Nora Helmer and Hester Prynne remain enduring symbols of resilience, independence, and the ongoing fight for women's rights.
